



Definition of School Nursing



"School nursing, a specialized practice of nursing, protects and promotes student health, facilitates optimal development, and advances academic success. School nurses, grounded in ethical and evidence-based practice, are the leaders who bridge health care and education, provide care coordination, advocate for quality studentcentered care, and collaborate to design systems that allow individuals and communities to develop their full potential."

School Nursing Services

- Assessing the severity of illness or injury in students.
- Distributing medications to student that is provided and approved by their parents and healthcare providers.
- Caring for students with chronic conditions such as diabetes, epilepsy/seizures, asthma, allergies/anaphylaxis, and others.
- Ensuring all students are up to date on their vaccinations/immunizations.
- Directing the provision of health services within the school.
- Screening students for vision, hearing, and other potential health issues.

- Preventing and controlling the spread of communicable diseases.
- Connecting students and their families to relevant health resources.
- Providing mental health support to students in need.
- Collecting health data in schools to provide to local, state, and national officials.
- Promotion of overall school community health through education and wellness initiatives.



School Nursing in Ohio

"The board of education may also **employ registered nurses**, as defined by section <u>4723.01</u> of the Revised Code, to aid in such inspection in such ways as are prescribed by it, and **to aid in the conduct and coordination of the school health service program**."

ODH SBHC History

- American Rescue Plan Act (ARPA) Funding- SFY23 and SFY24.
 - Funded by CDC's workforce grant and Ohio Department of Education and Workforce (ODEW) Governor's Emergency Education Relief (GEER) fund.
 - \$18.7 million from CDC workforce for operational costs and \$9 million from ODE GEERS for capital costs.
 - Fourteen SBHC healthcare partners.
 - Two contracts:
 - Nationwide Children's Hospital.
 - Ohio School-Based Health Alliance.



ODH SBHC History

General Revenue Fund (GRF) Funding- SFY24 and SFY25.

- \$7.5 million/year.
- Three solicitations released:
 - Continuation funding 12 ARPA funded sites funded.
 - Planning to Implementation Two health partners funded.
 - Expansion funding Six health care partners funded.
- Continued contracts:
 - Nationwide Children's Hospital.
 - Ohio School-Based Health Alliance.

- Educators/school staff:
 - Focus on teaching.
- Parents/caregivers:
 - Remain at work.

Benefits of Having Both School Nurses and SBHCs

School nurses and SBHCs work together to:

- Support healthcare and education which includes funding/reimbursement and policy development/implementation.
- Communicate to ensure continuity of healthcare services inside and outside the school setting.
- Coordinate care, thus providing best student outcomes, and ensuring students are healthy, safe, and ready to learn.
- Collaborate to address both social needs and to help alleviate social determinants of health and their causes.

Best Practices



ODH Program Collaboration

The Adolescent Health and School Nursing Programs work closely to align efforts related to the provision of school health services.

- Monthly full team meetings include:
 - Problem solving through respectful and reciprocal communication.
 - Clarification and coordination of roles.
 - Sharing of expertise and resources.
 - Development and review of data metrics to improve health services.
- Jointly attend and collaborate on agency and statewide workgroups and project teams to support a focus on child and adolescent:
 - Health outcomes.
 - School attendance.
 - Social determinants of health.
 - Seamless health services for families.



Strategies for Success

- Regular, weekly check-ins with school nurse.
- Establish protocols for communication between SBHC staff and school nurse.
 - Address confidentiality, safety, and privacy concerns.
 - Discuss SBHC consent for services, including responsibilities for obtaining paperwork.
 - Establish after care summaries that may be shared with school nurse/families to promote continuity of care.
- Create a frequently asked questions (FAQ) document for school staff.
- Partner with school nurse to increase support for and drive utilization of the SBHC.
 - Jointly establish a referral protocol.
 - Develop bi-directional standard operating procedures.
